The material below describes the privacy practices for the National Truck and Heavy Equipment Claims Council web site (the "NTHECC Site"). Additionally, to view the terms and conditions governing your use of this NTHECC Site, please see our Terms of Use.

Information We Collect; Use of Information

When you visit the NTHECC Site, our web server automatically gathers information from your Internet browser. This information may include your Internet protocol (IP) address (which allows us to determine the identity of your Internet Service Provider), your operating system, and the type of browser software that you are using to access the site. However, no personal information is ever gathered by us through your browser. This information is used solely to improve the content of the NTHECC Site.

We collect no other information from you unless you choose to provide us with information, such as name, postal address and e-mail address, so that we may respond to comments and questions about our services and the NTHECC Site. If you provide us with such information, it will be used only for the purpose for which the information was submitted. We will not share your information with any third party.

Use of Cookies

The NTHECC Site does not currently use cookies, small text files placed on a visitor's hard drive that are used by some web sites to retain information about visitors and for record keeping purposes. We reserve the right to change our policy regarding the use of cookies. If we do use cookies in the future, you can choose not to receive a cookie file by enabling your web browser to refuse cookies or prompt you before accepting a cookie. At no time will we store sensitive information, such as your name or e-mail address, in a cookie.

Security

We realize that foremost in the minds of privacy-conscious individuals is the security of information after its submission. All information collected through the NTHECC is securely stored in databases. Access to the stored information is restricted to select authorized personnel. Transmitting information via the Internet, however, is never completely secure; any information submitted may be intercepted, collected, used or disclosed by others. We use appropriate technology to minimize that risk.

The NTHECC Site contains hypertext links to third party web sites. Our Privacy Policy does not apply to such web sites and your use of such sites will be subject to the privacy policies and procedures relating thereto.

Intended for Adults Only

The NTHECC Site is intended for use only by adults. We will not knowingly solicit, collect or maintain personal data or information from children under the age of 18.
